NOTICE OF THE ANNUAL GENERAL MEETING

NOTICE is hereby given that the Twelfth (12th) Annual General Meeting ("AGM") of the Members of Future Retail Limited ("the Company") will be held on Tuesday, 30th July, 2019 at 11:30 AM at Rangaswar, Fourth Floor, Y. B. Chavan Centre, Gen. Jagannath Bhosale Marg, Mumbai - 400 021, to transact the ordinary and special business as set out in the Notice dated 25th May, 2019 convening the said AGM.

The Notice of the AGM together with the Annual Report for the year 2018-19 which *inter-alia* comprises of the Audited Financial Statement of the Company for the financial year ended 31st March, 2019 and the Reports of the Board of Directors and Auditors' thereon, has been sent to the Members whose name appeared in the Register of Members / Register of Beneficial Owners as on close of business hours on 28th June, 2019 as maintained by the Depositories Participants / Registrar & Share Transfer Agents of the Company (R&T Agents) through permitted mode.

The Annual Report along with the Notice, Attendance Slips and Proxy Form are available on website of the Company: <https://www.futureretail.co.in> and can also be downloaded from weblink: <https://www.evoting.nsdl.com>. The said documents are also available at Registered Office for inspection during normal business hours (9:00 AM to 5:00 PM) on all working days till the date of AGM. Even after registering for e-communication, Members are entitled to receive such communication in physical form upon making a request for the same, by post free of cost. E-VOTING INFORMATION: In compliance with Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended by the Companies (Management and Administration) Amendment Rules, 2015, Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Secretarial Standard on General Meetings issued by The Institute of Company Secretaries of India from time to time, the Company is pleased to provide its Members, the facility to exercise their right to cast their vote by electronic means in respect of resolutions as set out in the Notice, through e-voting services ("**remote e-voting**") as provided by National Securities Depository Limited ("**NSDL**") at the link <https://www.evoting.nsdl.com>.

Any person, who acquires Equity Share(s) and become Member of the Company after dispatch of the Notice and holding shares as of the cut-off date i.e. 23rd July, 2019, may obtain the login ID and password by sending a request at evoting@nsdl.co.in or mt.helpdesk@linkintime.co.in. However, if Member is already registered with NSDL for remote e-voting, then Member can use existing user ID and password for casting vote. If you forgot your password, you can reset your password by using "Forgot User Details / Password" option available on www.evoting.nsdl.com or contact NSDL at the toll free no: 1800-222-990.

The business as set out in the notice may be transacted by remote e-voting. The remote e-voting period shall commence on Friday, July 26, 2019 (9:00 AM) and ends on Monday, July 29, 2019 (5:00 PM). During the remote e-voting period, Members of the Company holding shares either in physical form or in dematerialised form as on the cut-off date i.e. 23rd July, 2019, may cast their vote through remote e-voting. The remote e-voting module shall be disabled by NSDL for voting thereafter. Once, the vote on resolution(s) is cast by the Members, the Members shall not be allowed to change it subsequently.

Members may participate in the AGM even after exercising their right to vote through remote e-voting but shall not be allowed to vote again in the AGM. The facility for voting through Polling Paper shall be made available at the AGM and the Members attending the AGM who have not cast their vote by remote e-voting shall be able to exercise their right at the AGM through Poll.

A Member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on a poll instead of himself/herself and the proxy need not be a Member of the Company.

The Company has appointed Ms. Bindu Darshan Shah (Membership No. A-20066 / CP No. 7378), Proprietor - M/s. K Bindu & Associates, Practising Company Secretaries as the Scrutiniser to scrutinise the remote e-voting process and voting conducted through Polling Paper at the AGM in a fair and transparent manner.
